Qty	SCOPE OF PROPOSED WORK
250	- INSTALL 90 DEGREE DRIP METAL ON ALL PERIMETER EDGES
10	- INSTALL ICE SHIELD 52" UP FROM THE DRIP EDGE AND ALONG ALL EAVES. 3' OF ICE SHIELD WILL ALSO BE PLACED IN EACH VALLEY. ( NOTE: LOCAL BUILDING CODES, HAVE RECENTLY CHANGED REQUIRING ICE AND WATER SHIELD TO BE INSTALLED 2' BEHIND WARM WALL.)
25	- INSTALL SYNTHETIC UNDERLayment ON ALL SURFACES NOT COVERED BY ICE AND WATER SHIELD. (SYNTHETIC UNDERLayment IS STRONGER THAN STANDARD FELT UNDERLayment)
35	- INSTALL CERTAINTEED LANDMARK 30 SHINGLES USING 6 NAILS PER SHINGLE FOR INCREASED RESISTANCE AGAINST SHINGLE BLOW OFFS.
150	- INSTALL CERTAINTEED HIP AND RIDGE
5	- FLASH ALL PIPES WITH STEEL PIPE FLASHINGS. 18" ICE SHIELD WILL BE INSTALLED ON FLASHINGS. PIPES WILL BE PAINTED WITH PAINT SIMILAR IN COLOR TO THE SHINGLES
1	- FLASH METAL FLUE PIPES WITH STEEL PIPE FLASHING. PAINT FLASHING AND PIPE.
30	- INSTALL APPLICABLE ICE SHIELD AND FLASHINGS OR ICE SHIELD AND MASTIC DETAIL AGAINST ALL WALLS
40	- SHINGLE VALLEYS USING CALIFORNIA CUT VALLEYS.
8	- INSTALL STEEL BACK TURTLE VENTS ALONG RIDGE. PAINTED GALVANIZED FINISH
